

# Terms and Conditions



The hirer (person's hiring our equipment) agrees to details as described in the agreement as listed. Fees charged as outlined throughout.  
This agreement is in (AUD) Australian Dollars only.

## **Booking Fees :**

Off the Beat 'N' Track Camper Trailer Hire will temporarily book over the phone and hold that booking for a period of 24 hours as agreed. or until a 10% Booking Deposit is Required to be paid to confirm Booking. ( Non Refundable )

## **Payments:**

**All Camper Hires to be Paid for in full at time of collection or prior to Collection**

## **Booking Period:**

The hirer will be charged for all camper trailer and equipment hired on a agreed time basis. Hire of our equipment is for the agreed time only, we will endeavour to accommodate any extensions if possible.

## **Bond:**

A \$500.00 cash / credit card bond is required on collection of the camper trailer ( **Western Australia Travel only** )

A \$800.00 cash / credit card bond is required on collection of the camper trailer ( **For Interstate Travel** )

(this bond covers incidents such as canvas damage, tyre damage and cleaning if required).

A \$50.00 Treg hitch pin and lock deposit bond is included in this amount.

This bond could be held back for any unreasonable wear and tear or malicious damage on the camper trailer.

## **Bond Return:**

Your bond will be refunded within 7-10 days (either by cash or cheque ) from the time the equipment has been returned and been examined.

## **Insurance:**

A \$1000.00 excess is payable by the hirer in the event of an accident which is payable immediately.

## **Pickup & Delivery:**

Pickup and returns must be done between 9:00am and 5:00pm Monday to Friday and on Saturday 9:00am - 4:00pm. Sundays and Public Holidays unless by prior arrangement with Off The Beat 'N' Track.

If goods are returned outside these times a fee may apply.

## **Payment:**

Off the Beat 'N' Track Camper Trailer Hire accepts payments in Cash, Direct Deposit, (we will supply account details upon request), Money Order, Bank Cheque E.F.T.P.O.S. (American Express or Diners cards are NOT accepted)

## **Cleaning & Repairs**

Before all hires, our equipment is cleaned and maintained to our schedule and should be returned in the same condition. **A \$50.00 cleaning fee will apply if the equipment is not returned in a clean condition.**

Marks on the canvas are to be wiped off with a cloth and water only. (Strictly no cleaning chemicals are to be used on the canvas as this may damage the waterproofing properties of the canvas).

If the equipment is returned damaged the hirer agrees to pay Off the Beat 'N' Track Camper Trailer Hire the reasonable cost to the repair and also will pay rental on the equipment at half of a rental rate until repairs are completed. Repair of



### **Cancellation Fees**

A cancellation fee ( Booking Fee ) will apply on hire cost if cancelled with less than (1) weeks notice.

### **Smoking**

Smoking is not permitted in the confines of the camper trailer or canvas areas attached to the camper trailer.

### **Corrugated Roads**

When travelling on corrugated roads a maximum speed of 60km perhour must be adhered to.

### **Identification & Age Requirement:**

**Off the Beat 'N' Track Camper Trailer Hire** requires two forms of identification prior to the hiring of our camper trailers and equipment with one form of ID showing a photograph. (EG: Drivers License or Passport). Also required is proof of the hirer's current residential address and contact details.

The driver of the towing vehicle to be older than 25 years of age. Driver of the towing vehicle is to be an experienced driver. No 'P' plate drivers.

### **Late Returns:**

All our Camper trailers and equipment are booked on a 24 hour basis. If Camper trailer and equipment is picked up at 9:00am, it is then due to be returned at 9:00am the following day. Late returns will be charged at a daily rate unless with prior agreement with Off The Beat 'N' Track Camper Hire.

### **Early Returns:**

There is no future credit and no refund given as a result of early return of the camper trailer and equipment hired.

### **Return of Camper Trailer:**

The hirer agrees that, under any circumstance whatsoever to allow the managers of Off the Beat 'N' Track Camper Trailer Hire, or any representative nominated by us, to enter the hirer's premises, or premises where the trailer has been parked, abandoned or left by the hirer or any person in the company of the hirer, in order for us to resume possession of our camper trailer and equipment.

### **Damages:**

The hirer agrees that, Off the Beat 'N' Track Camper Trailer Hire and any of its known affiliates are not accountable for any costs incurred to the hirer as a result of damage to or theft of any of our equipment during the period of hire.

Costs such as accommodation, meals, flights, car hire, phone calls or any other costs incurred are at your own expense.

It is the responsibility of the hirer to exercise care of the camper trailer and equipment while it is in their possession.

All damages to our equipment while in the possession of the hirer must be reported immediately to the management of Off the Beat 'N' Track Camper Trailer Hire.

All damages sustained to the camper while in the possession of the hirer shall become the sole responsibility of the hirer to repair. All repairs are to be undertaken only as authorised by the management of Off the Beat 'N' Track Camper Trailer Hire using qualified service personnel nominated by us. All costs for repairs required as result of damage while on hire shall be paid for by the hirer.

**Under no circumstance shall any third party be engaged, or act on behalf of the hirer for the purpose of repairs unless specifically authorised in writing by Off the Beat 'N' Track Camper Trailer Hire.**
